- → Crossing a Runway
- → Exiting the Movement Area

Radio Communications and Phraseology

Glossary

- → Affirmative: Yes
- → Off: No longer located in movement area/safety area
- → Go Ahead: State your request
- → Hold: Stop where you are
- → Hold Short Of: Proceed to but hold short of a specific point
- *→ Negative*: No
- → Proceed: Authorized to begin or continue moving
- → Read Back: Repeat my message back to me
- → Roger: Received & understand all of your last transmission
- → Say Again: Repeat what you just said
- → Standby: Wait
- → Without Delay/Expedite:
 Proceed in a rapid/safe manner
- → State who you are calling
- → State who you are
- > State where you are
- → State what you want to do
