## AIRPORT SMS: WORKING FOR YOU NOTABLE IMPROVEMENTS

On March 1, 2013, the Airport established an online reporting system that enabled all of our airline partners, concessionaires, tenants and Airport employees to report potential hazards. In 2014, the Airport received 76 reports. A full breakdown of the year can be found on Page 3 and 4.

Notable Improvements in 2014:

- Installed foam edge bumpers on all T1 Bag Room Inbound Baggage Carousel card reader support devices;
- Provided recycling options for deicer fluid and deicer totes;
- Covered numerous open junction boxes in the T1 Bag Room;
- Installed crosswalk and ramps at Exit 18, Arriving Flights Drive, Terminal 1;
- Installed permanent concrete step near Gate C24, Rampside;
- Painted six new stop bars (signs) on the Vehicle Service Roadways, throughout the Non-Movement area;
- Established a routine cleaning schedule of the T1 Bag Room (City-maintained areas);
- Removed former trash chute structure near Gate C8, Rampside;
- Leveled floor-mounted electrical outlets, Terminal 2, post security;
- Painted low clearance pillars and re-striped parking spots, Terminal 1 Parking Garage, Red Level;
- Replaced metal expansion joint near Gate A16, Concourse Level;
- Updated *public-use* automated external defibrillator (AED) maps and associated inspection forms (Terminal 1, Terminal 2, A & C Concourse);
- Installed exit sign and emergency egress lighting, Airport Properties Conference Room, T1;
- Rearranged seating to allow unobstructed access to Emergency Exit door, Gate C19 holdroom area; and
- Implemented new Ramp Speed Limit policy.





#### STL SMS REPORTING: 2014 YEAR-IN-REVIEW STATISTICS




#### **Total Reports Received By Month**

**Reports By Entity** 




**Reporting Methods** 




#### **Reports By Outcome**






#### STL SMS REPORTING: 2013 / 2014 COMPARISON

### **Total Reports Received By Year**




#### STL SMS REPORTING: 2013 / 2014 COMPARISON

### FOREIGN OBJECT DEBRIS (FOD)

On Saturday, June 28, 2014, the *FOD Brigade*, made up of 26 Airport, Airline and Tenant volunteers, supported by Airfield and Building Maintenance personnel, participated in the second annual STL FOD Walk. Focusing on the A Concourse, the Brigade collected numerous bags of trash, wooden pallets and other items. In addition, a team picked up FOD along Tug Road from the Host Commissary to the beginning of the D Concourse in an effort to make STL a safer place to work and operate.



The 2nd Annual FOD Walk was generously supported by AIG, AON Risk Solutions, Boeing Test and Evaluation – Military Tactical Flight Operations, Crawford, Murphy & Tilly, Inc. ## **Ramp & Airfield Driver Presentations**

In November, SMS slides were added to both the Airline Ramp Safety Procedures PowerPoint presentation and the Radio Procedures and Airfield Familiarization PowerPoint presentation. These four new slides define SMS, provide information on hazard identification, and provide methods for confidential hazard reporting.



#### MINI FOD REMOVAL OPERATIONS

The Airport is committed to eliminating FOD on the Ramp. In addition to the 2nd Annual FOD Walk, STL conducted numerous "mini" FOD removal operations including:

- Removal of jetway parts, metal, wooden boxes and tires near Perimeter Gate 16S and HMSHost Commissary;
- Removal of jetway chute and parts near Gate A3;
- Removal of pipes and roadway barrels near Gate E29;
- Removal of pallets, leaves, debris, desk and chair near Gate E40 & E34;
- Removal of pallets near the northeast corner of Cargo City;
- Removal of metal cages near Gate B3; and
- Removal of computer parts and building supplies just east of Gate E34.
